# **Code updates effective in January 2022**

The Code on Dental Procedures and Nomenclature (the Code), commonly known as Current Dental Terminology, or CDT, is the current HIPAA-designated code set used in electronic dental data interchange. As such, the Code is the national standard for reporting dental services and is the principal means of communication between dentists and dental benefits payers.

Any dental claim submitted electronically on a HIPAAstandard electronic dental claim must use procedure codes from the current version of the Code. The Code is also used for dental claims submitted on paper.

The Code is regularly updated to reflect changes in dental procedures accepted by the dental community. The Code is now reviewed and revised by the American Dental Association (ADA) on an annual cycle, with each revised



version effective on January 1 every year.

A revised version of the Code, as published by the ADA in the manual titled "CDT 2022: Dental Procedure Codes," will be effective January 1, 2022, for services provided on or after January 1, 2022, through December 31, 2022.

The 2022 version of the Code incorporates a significant number of procedure code changes, with 16 new procedure code entries, five deleted code entries and 22 revised procedure code entries. Five of the revised entries were only editorial changes (e.g. changes in syntax or spelling).

Among the 43 procedure code changes for 2022 are: two codes in regards to splinting (intra-coronal and extracoronal), two new immediate partial denture codes (maxillary and mandibular flexible base), a code to be used for the rebase of a hybrid prosthesis, a code for the soft liner of a removable complete or partial denture, a code to be used in regards to the removal of an interim implant component, three codes in regards to the removal of temporary anchorage devices, a code to be used for pre-visit patient screenings, and three codes in regards to sleep apnea appliances (one code for the appliance, one for the adjustment of the appliance, and one for the repair of the appliance).

Along with the CDT 2022 procedure code changes, the following claim and processing procedures will be effective January 1, 2022:

### Benefit coverage:

- Code **D3921** will be benefited under individual consideration.
- Code **D5725** will be covered once in a five year period.
- Code **D5765** will be covered once in a three year period along with other existing reline procedures.

### New procedure codes and associated processing policies:

#### **Endodontics:**

D3911 (intra-orifice barrier) An intra-orifice barrier is considered part of the root canal procedure (D3310–D3348) and the fees are not billable to the patient.

#### **Periodontics:**

D4322–D4323 (splint—intra-coronal/extra-coronal; natural teeth or prosthetic crowns) The fees for intracoronal splints submitted in conjunction with prosthetic crowns (D2700–D2799), implant prosthetics crowns (D6058–D6067, D6082-D6085, D6086–D6088, D6094, D6097), fixed partial dentures (D6205–D6794) and implant fixed partial denture retainers (D6068–D6077, D6098, D6099, D6120–D6123, D6194, D6195) are not billable to the patient.

# **Implant services:**

D6198 (remove interim implant component) Fees for removal of an interim implant component by the same dentist/dental office who placed the implant component are considered part of the interim abutment placement procedure and are not billable to the patient.

#### Oral and maxillofacial surgery:

D7298–D7300 (removal of temporary anchorage device [screw retained plate, requiring flap]/[requiring flap]/[without flap]) The fee for removal of a temporary

anchorage device is included in the surgery and is not billable to the patient when done by the same dentist/dental office as the placement of the device.

# Adjunctive general services:

D9912 (pre-visit patient screening) The fee for a pre-visit patient screening is not billable to the patient. D9948 (adjustment of custom sleep apnea appliance) When a benefit of the group/individual contract, the fees for adjustments custom sleep apnea appliance, if performed within six months of initial placement by the same dentist/dental office are not billable to the patient. D9949 (repair of a custom sleep apnea appliance) Fees for repair of custom sleep apnea appliance, if performed within six months of initial placement by the same dentist/dental office are not billable to the patient.

With all the new code changes, we recommend that dentists and dental offices verify covered services for patients before rendering treatment. Details of individual coverage can be verified by logging in to the Dental Office Toolkit \*\*.

# Medicare Advantage™ Network Fraud, Waste and Abuse training reminder

As a reminder, the Fraud, Waste and Abuse, Compliance, and Cultural Competency training shall be completed once each calendar year for providers who participate in the Delta Dental Medicare Advantage™ network. Please follow the steps outlined below to compete the annual training at your earliest convenience.



- 1. Follow the <u>link</u> to the Delta Dental of North Carolina website
- Click the **DOWNLOAD** button to review the FWA, Compliance, and Cultural Competency Training
- Clicking "Download" will open a new browser
  window where you can view the training. You will
  not need to print the document and there is no
  test required. You may close the browser window
  displaying the training once it has been reviewed.
- 3. Click the **SIGN** button to complete and submit the Training Acknowledgment Form.

- Training is tracked by the Tax Identification
  Number (TIN) used to submit claims to Delta
  Dental. An acknowledgment form must be
  submitted for each active TIN in order to be
  marked complete. Only one dentist or staff
  person needs to submit an acknowledgment
  form per TIN.
- 4. Receive your confirmation email.
- A confirmation email will be sent to the email address entered on the acknowledgment form.
   Please keep in mind, the confirmation email is only valid for the TIN entered on the acknowledgment form. If the TIN entered does not match our records or was entered incorrectly, a new form will need to be submitted with the correct TIN to order to be marked complete.
